## Daylight Saving Time in the US

In most of the US, Daylight Saving Time (DST) begins on Sunday, March 10, at 2 AM local time. Set clocks ahead by 1 hour. The start of DST does not affect Universal Coordinated Time (UTC), also known as Greenwich Mean Time (GMT) or simply Zulu (Z), although some transceiver clocks generate UTC based on a specified difference from the local time setting. UTC is the generally recognized "standard time" for Amateur Radio log keeping. In any case, in those areas observing DST, the difference between UTC and local time will be 1 hour shorter.

Daylight Saving Time this year ends on Sunday, November 3, at 2 AM local time — which is in the middle of ARRL November Sweepstakes CW weekend.

The changeover to or from DST is an ideal occasion to check the serviceability of any smoke, gas, and carbon monoxide detectors and replace batteries with fresh ones, if necessary. It could save your life!

## Ofcom News

### **Love Sport and Panjab Radio to change frequencies? .....9 February, 2019**

Ofcom has received a request from Love Sport and Panjab Radio to swap the format of each licence.

Love Sport currently broadcasts London-wide with a coverage area of over ten million adults on 558 AM on the licence originally started by Spectrum Radio in 1990. The Kelvin Mackenzie-owned station launched in March 2018 on AM and DAB and has had a format change approved last year to remove finance news from its character.

Panjabi Radio is covering North London on 1584AM on the licence won by London Turkish Radio, which also launched in 1990.

Love Sport owner ASSL says it wishes to change the ‘Character of Service’ of its station’s published Format for the Greater London coverage area from “A 24-hour speech service for Londoners focussing on sports plus some topical content and local information” to, “The service will be known as Panjab Radio and will provide a service aimed at the Panjabi community. The service will be broadcast in Panjabi and English languages.”

PRRL, owner of Panjab Radio, says it wishes to change the ‘Character of Service’ of its station’s published Format for the North London AM coverage area from, “The service is known as Panjab Radio and will provide a service aimed at the Panjabi community. Embracing Panjabi culture and language with spiritual music and the celebration of festivals for a variety of religions. The service broadcast in Panjabi and English languages.” to “A 24-hour speech service for Londoners focussing on sports plus some topical content and local information”.

Ofcom has taken a preliminary view on the requests and says it is minded to grant them but is seeking views before making a decision. The regulator says the requested changes to the characters of the relevant services would not narrow the range of programmes available by way of relevant independent radio services to persons living in the North London coverage area, and that there is evidence of sufficient demand and support for a change to the existing character of service for the Greater London licensed area, it is minded to consent to the requests subject to the outcome of the consultation.

Ofcom’s policy regarding changes, including substantial changes, to AM station Formats, is that it is likely to be more willing to agree them than would be the case for FM stations.

The move would give Panjab Radio coverage across Greater London, whilst reducing Love Sport’s output to the North of the capital. The consultation closes at 5pm on 8 March 2019.

## BBC News

### **BBC Auditions For Presenters .....30 January, 2019**

The BBC is launching a huge search for new broadcasting talent as it seeks to reinvent its local radio stations. Open auditions to be held across England to find the radio stars of tomorrow

Open auditions will be held across England to find new presenters. The aim will be to offer successful candidates regular shows on their local station.

The talent search is a key part of an ongoing plan to reinvent BBC local radio, first announced by the Director-General of the BBC Tony Hall in November 2017.

Last year, in the biggest shake-up in a generation, each station launched 15 hours of new, original content every week. It came after the shared weekday evening programme was axed in October.

The replacement local evening shows have focused on bringing new talent to the BBC and covering subjects not usually heard on BBC local radio.

An award-winning London comedian, a former Leeds United footballer, the current Lord Mayor of Sheffield Magid Magid, a finalist on The Voice, and the 24-year-old director of music at Pembroke College, Cambridge are just some of the new stars getting their first break in broadcasting in the new evening line-up. ### **Baur Acquires Additional Stations .....5 February, 2019**

Bauer Media Group is acquiring Celador Radio and Lincs FM Group, a total of 34 regional stations that will add 1.1 million weekly listeners to the media owner's portfolio.

The deal will extend Bauer's reach in the UK and builds on its other acquisitions, such as Jazz FM last year and Orion Media in 2016.

Bauer is also selling The Breeze and Sam FM in the Solent region and KCFM in Yorkshire to Nation Radio because it already has stations in the areas – Wave 105.2 FM and Viking Radio.

The media company said it is continuing to look for "opportunities to further extend its portfolio in the UK and Europe".

Bauer launched Hits Radio last year and is introducing a new classical radio station, Scala, next month.

Paul Keenan, chief executive of Bauer, said: "Bauer's strong position on new listening platforms – with more than 60% of our listening now digital – will help secure the future of the acquired stations in the new audio world.

"Through this investment, Bauer Media is demonstrating its fundamental belief in the UK, one of its key markets, which it is certain will continue to offer great opportunities for growth and economic success and in the continuing relevance of radio as a medium."([www.radiotoday.co.uk](http://www.radiotoday.co.uk))

### **Further Additional Stations .....8 February, 2019**

Bauer Media has announced that it will acquire Wireless local stations across England and Wales.

## RSL & LPAM News

**NH Sound 1287 kHz** LPAM is off the air. According to a report in the Abergavenny Chronicle (23 January) the transmitter has been switched off and studio equipment has been moved by new bosses to a new location in the Tredegar area. There has been a walk-out of long time presenters following a dispute over the new-direction the station. A statement on the website says “Trustees have taken the decision to switch off our radio transmitter due to a recent loss of sponsorship. We are hopeful this will change in the near future”. In addition to the move it was also agreed to rebrand the station to bring it into modern times. Services will still be readily available to the hospital via the Internet. Currently this is the only method of directly broadcasting to hospital wards as there are no remaining hospedia units at Nevil Hall Hospital”.

**Radio Glan Clwyd 1287 kHz** has closed from 31 January. This community radio station had broadcast from Glan Clwyd Hospital in Bodelwyddan for several years, initially with an LPAM licence and since 2014 with a community radio licence. It has now been removed from Ofcom’s list of community stations. Reason for the closure is not known, the web site is out of date although it still had an audio feed at <http://radioglanclwyd.co.uk> when checked on 2 February.

**Radio Seerah Leicester 1575 kHz** started transmitter testing on 31 January just in time for its launch on 1st February. This new community station was awarded a licence in May 2017 and is aimed at the Muslim community in Leicester. Web site [www.radioseerah.com](http://www.radioseerah.com) EMRP not yet confirmed but is in the region of 2 Watts. Confirmed with a weak signal in Buxton, its a difficult frequency with co-channel interference. (Nick Rank, David Thorpe 31 Jan)

Another medium wave community station is due to launch this year in Glasgow, **Ark AM**, which is also aimed at the Muslim community, its frequency will be **1530 kHz**.

**Harrogate Hospital Radio** is a new planned LPAM on **1386 kHz** (1 Watt). It has been added to Ofcom’s transmitter list effective from 26 November but does not yet seem to be on the air. (Details of all these stations courtesy of BDXC-Communication February 2019)

**Acacia Radio 1287 kHz** is back on air. Broadcasting from Annesley, Nottingham. (thanks to our Hon President Bernard Brown). The station was previously using this frequency but in June 2016 moved to “on line” only. There is nothing at present on their web site to say they are now broadcasting on this frequency.

## Irish News

### Irish Listening Figures .....5 February, 2019

Some 3.17m adults – or 83% of adult population – tune in to a radio station every day, each spending on average of four hours per day listening, according to the latest batch of research figures from the JNLR.

The research for the JNLR, which was carried out by Ipsos MRBI, also shows that when it comes to audio listening in Ireland, live radio dominate’s with an 85.5% share of all listening. This compares to 8% for owned music, 1.6% for podcasts and 4.9% for Spotify.

“The JNLR results share a very positive story about the power of radio in Ireland. Radio doesn’t sell advertising space, it sells the ability to reach a huge audience and the results out today show that 3.1 million people every day tune into Irish radio. These audiences are in every county in Ireland and include listeners of every age group from 15 years upwards,” says Gabrielle Cummins, chairperson of the Choose Radio Group.

“Radio talks directly to the ears of 83% of people every single day and that is a strong selling point to brands, businesses and advertising agencies. In addition, with radio audiences tuning in for an average of 4 hours a day and while a 30 second message may seem short, on radio it will resonate with more people, more often, reinforcing that crucial message that brands want communicated effectively,” she adds. ## National Commercial Breakfast Shows

The three largest Commercial radio stations in the UK announced that they have decided to launch Nation-wide breakfast shows. It looks like end of "local" stations.



Global media has announced today 26 February 2019 it will launch UK-wide national breakfast shows on Capital, Heart and Smooth radio.

Global say they will be creating the three largest commercial radio breakfast shows in the UK, with 4.8m, 3.7m and 2.7m listeners respectively each week.

But it means a reduction in locally produced programmes, with more than 100 jobs at risk due to the changes. Ofcom has approved the move following a change in guidelines for local radio.

Capital will launch their network breakfast show first in April, with Heart and Smooth following later in the year.

- \* Capital London's breakfast show will replace 14 breakfast programmes on the Capital network in England, Scotland and Wales
- \* Capital will have nine drivetime shows (including London, Liverpool, North East and Yorkshire) instead of the current 14
- \* Heart will have a single breakfast show across England, Scotland and Wales instead of the current line-up of 22 breakfast shows
- \* Heart will carry 10 drivetime shows instead of the current 23 separate drivetime shows
- \* Smooth will create a new national breakfast show replacing breakfast programmes in East Midlands, West Midlands, North West, Lake District, North East, Scotland and Wales
- \* Smooth's drivetime programmes will be reduced to seven

Global says local news and travel information "will continue to air on a local licence level as per legislation requirements" .But it said its news teams would see "refreshed structures" along with engineering and marketing.

[Analysis by Radio Today](#) said that 95 local radio presenters could lose their jobs as a result of the changes.

The changes will also mean the closure of broadcast facilities. The sites earmarked for closure are Brighton, Cambridge, Chelmsford, Exeter, Gloucester, Kendal, Kent, Lancaster, Norwich and Swindon.

Global's revamp is likely to be replicated at its biggest commercial rival, Bauer, which owns stations like Kiss, Absolute and Magic.

The companies have been given the go-ahead by broadcasting regulator Ofcom, which relaxed its rules on how and where stations make their programmes last October. Stations still need to apply to change their formats, and Ofcom has published a number of approved format changes for Global Radio stations across the UK. Ashley Tabor, Global's founder, told staff the news at a meeting on Tuesday and said it "would mean change". Yet he also said "the ability to lead the commercial radio sector's next huge step, and to properly compete with BBC Radio 1 and 2 at breakfast time"

Local legend Boss Hogg recently launched a new radio station out of his famous Plant City Farm & Flea Market.

Ferris Waller, known to many as Boss Hogg, has played a key role in establishing foundational enterprises throughout not only Plant City, but much of central Florida.

He is the mastermind behind the Plant City Farm & Flea Market and his newest venture is bringing his eclectic taste into homes throughout the area. Thanks to Boss Hogg Plant City once again has a hometown radio station.

“Our saying is we don’t play opera, heavy metal, punk rock, rap or crap,” Waller said. “In the morning it’s heavy country, we call it ‘Heinz 57 music,’ which means its a wide variety of music. It’s what I enjoy and I think a lot of other people will enjoy it, too.”

Waller said he listened to Al Berry and Ercell Smith at WPLA. When he found out a Winter Haven station was up for sale he decided he would purchase it and bring a station back to Plant City.

Waller is the epitome of an entrepreneur. When he realized the limitations in place at the Plant City Farmers Market he decided to create one where anyone could come and sell their wares.

He started off with one-half acre and seven vendors. Now he has approximately 40 acres and more than 100 vendors. The flea market on Wednesdays attracts more than 375 vendors with more than 2,500 customers every week. He said they’ve even had trucks come from as far as Canada to sell and buy produce.

An economic impact study by Allen W. Hodges, Ph.D., an extension scientist with the University of Florida’s Food and Resource Economics Department, in 2017 found that annual sales of the market are more than \$177 million, which impact nearly 3,200 full and part-time jobs.

On top of the highly successful market, Waller owns several other businesses including a metal roofing shop, a sign shop, I-4 power equipment, an RV park, Kathleen’s Garden & Grandpa’s Event Barn and several restaurants throughout central Florida.



“I’m the only kid in my class that owns six businesses to make a living,” Waller said. “I think I would have to say that practically everything I’ve done has been an accident. I went to Orlando one time to go to a metal roofing show and ended up at the wrong place. They were having a sign show instead. Next thing I knew I was opening a sign shop.”

Waller attributes his non-stop lifestyle to simply “trying to stay busy.” He joked the hope is it will keep him out of trouble. When he isn’t working at one of his many businesses he can be found on his ranch off Knights Griffin Road tending to his 75 head of cattle.

When he began creating River Ratz Cafe in Nobleton he handpicked the unique playlist of classic tunes that serenade customers all day long. He realized the ambiance worked and chose to carry that on in his new station.

Unlike many formal stations, Boss Hogg Radio is an open pod themed setup. When you walk through the door the hosts are all sitting around a table, their equipment grouped all together in the same room. It creates a “reality radio” aesthetic, Waller said. When something happens in the studio, listeners go along for the ride.

He said they’ve been told it will fail, but that the feedback they’re beginning to receive from listeners is indicating he may have once again been onto something. Working in the new studio didn’t lessen the itch. Waller is now finalizing negotiations for the radio station in Bushnell to further his reach.

His lineup is diverse and impressive. Listeners will hear everything from classic country to jazz, reggae and even disco. If it’s good music, it’ll come across the air, Waller said. Word began to spread of the unique setup Waller was creating down in Plant City. Soon he had people reaching out asking to be a part of his team.

A name many might recognize comes on every day from 9 a.m. to 12 p.m. for The Rocket Man Show with Johnny Rocket. The comedian has received national recognition and lives in Lakeland.

When he realized Plant City was about to get back into the broadcasting game Waller said he was right on board to join the movement. Many of the other broadcasters, like Charlie Brown from Polk County, are broadcast experts and have been on the radio for decades.

“I tell everyone this is the Boss Hogg Radio Station of has-beens and wanna-bes,” Waller said. “We are not as close to being professional as some of those other stations out there. When you tune in you’re going to have some fun because we are and listeners are a part of that.”

He’s poured his time, investments and heart into his community and said he is always looking for something that he is passionate about that can help the area continue to grow.

Waller’s 80th birthday was this week and he has no plans to slow down his pursuit of new ventures and uncharted territory.

“I’m just trying to get as much done in the few years I have left,” Waller said. “I would like to see Plant City have something of its own again, like it used to have.”



# The Worsening Cosmic Ray Situation

## Cosmic rays are bad – and they’re getting worse


March 5, 2018: That’s the conclusion of a new paper just published in the research journal Space Weather. The authors, led by Prof. Nathan Schwadron of the University of New Hampshire, show that radiation from deep space is dangerous and intensifying faster than previously expected.



The story begins four years ago when Schwadron and colleagues first sounded the alarm about cosmic rays. Analyzing data from the Cosmic Ray Telescope for the Effects of Radiation (CRaTER) instrument onboard NASA’s Lunar Reconnaissance Orbiter (LRO), they found that cosmic rays in the Earth-Moon system were peaking at levels never before seen in the Space Age.

The worsening radiation environment, they pointed out, was a potential peril to astronauts, curtailing how long they could safely travel through space.

This figure from [their original 2014 paper](#) shows the number of days a 30-year old male astronaut flying in a spaceship with 10 g/cm<sup>2</sup> of aluminium shielding could go before hitting NASA-mandated radiation limits:




In the 1990s, the astronaut could spend 1000 days in interplanetary space. In 2014 ... only 700 days. “That’s a huge change,” says Schwadron.

Galactic cosmic rays come from outside the solar system. They are a mixture of high-energy photons and sub-atomic particles accelerated toward Earth by supernova explosions and other violent events in the cosmos. Our first line of defense is the sun: The sun’s magnetic field and solar wind combine to create a porous ‘shield’ that fends off cosmic rays attempting to enter the solar system. The shielding action of the sun is strongest during Solar Maximum and weakest during Solar Minimum – hence the 11-year rhythm of the mission duration plot above.


The problem is, as the authors note in their new paper, the shield is weakening: “Over the last decade, the solar wind has exhibited low densities and magnetic field strengths, representing anomalous states that have never been observed during the Space Age. As a result of this remarkably weak solar activity, we have also observed the highest fluxes of cosmic rays.”

Back in 2014, Schwadron et al used a leading model of solar activity to predict how bad cosmic rays would become during the next Solar Minimum, now expected in 2019-2020. “Our previous work suggested a ~ 20% increase of dose rates from one solar minimum to the next,” says Schwadron. “In fact, we now see that actual dose rates observed by CRaTER in the last 4 years exceed the predictions by ~ 10%, showing that the radiation environment is worsening even more rapidly than we expected.” In this plot bright green data points show the recent excess:



The data Schwadron et al have been analyzing come from CRaTER on the LRO spacecraft in orbit around the Moon, which is point-blank exposed to any cosmic radiation the sun allows to pass. Here on Earth, we have two additional lines of defense: the magnetic field and atmosphere of our planet. Both mitigate cosmic rays.

But even on Earth the increase is being felt. The students of Earth to Sky Calculus have been launching space weather balloons to the stratosphere almost weekly since 2015. Sensors onboard those balloons show a 13% increase in radiation (X-rays and gamma-rays) penetrating Earth’s atmosphere:



X-rays and gamma-rays detected by these balloons are “secondary cosmic rays,” produced by the crash of primary cosmic rays into Earth’s upper atmosphere. They trace radiation percolating down toward our planet’s surface. The energy range of the sensors, 10 keV to 20 MeV, is similar to that of medical X-ray machines and airport security scanners.

How does this affect us? Cosmic rays penetrate commercial airlines, dosing passengers and flight crews so much that pilots are classified by the International Commission on Radiological Protection as occupational radiation workers. Some research shows that cosmic rays can seed clouds and trigger, potentially altering weather and climate. Furthermore, there are studies (#1,#2, #3, #4) linking cosmic rays with cardiac arrhythmias in the general population.

Cosmic rays will intensify even more in the years ahead as the sun plunges toward what may be the deepest Solar Minimum in more than a century.



# Radio Swan

Swan Islands are two coral and limestone islands lying at 17° 24 N and 83° 56 W or about 97 miles north of Patuca Point, Honduras. "Little Swan" is uninhabited. "Great Swan" is 2 miles long by ½ mile wide, and is inhabited by 20 Cayman Islanders – who grew coconuts, six employees of the US Federal Aviation Agency, and about 20 Radio Swan operators and engineers. The Swan Islands were declared a possession of the US in 1863, although they now seem to be privately owned by a Mr Smith of Boston. But, Honduras has been grumbling that it really owns the territory and recently Nicaragua began laying claim to it as well. Radio Swan solved this dilemma for themselves by paying Mr Smith the rent and not applying to any country for a radio transmitter license!

When Radio Swan went on the air 1960, its owners began selling commercial times. Many sponsors, among them some anti-Castro exiles from Cuba and some anti-Trujillo exiles from Dominican Republic.

When the Radio Swan situation began to get hectic, a group of Hondurans decided it was the time to take a firm stand on the Honduras claim to the Swan Islands. About a dozen brave souls set out from Honduras in a rented boat for "invasion".

After a rough trip, they "took the beach" and asked the boys at Radio Swan to give them some seasick remedies and to put out a location where they could run up a Honduran flag. The Radio Swan gang gave them a cordial welcome and directed them to an appropriate spot where they proceeded to "fly their colors".

Lunch was served by the Radio Swan people, and a parting gift of a bottle of Honduran made "Scotch" was given to the Swan Islanders by the "invasion party" before its return. A good time was had by all.

Radio Swan is still operating without a license and diplomats are still taking tranquilizers over the problem of who really owns the Swan Islands. Castro is still burning about the whole situation, and the land-bound Gibraltar Steamship Corporation is enjoying a profitable business venture.



On the air they announce their address as Radio Swan, Box 1247, GPO, New York but faster verifications can be had if you write to Radio Swan, c/o Gibraltar Steamship Corporation, 18 East Street, New York 22. Previously reported address is no longer correct.

The station is scheduled to operate on 1160 0500-0715 EST and 1800-2300 EST Mon-Sat, 1830-2315 EST Sun and on 6000 0800-1015 EST Mon-Sat, 1830-2215 EST Sun.







Station is branded as Isla 63 and is broadcasting from the village of Dededo, in the United States territory of Guam. The station's format is Chamorro music and Talk radio.


