



## Commercial Radio News

### **Listeners are Increasing their radio habits .....21 September, 2020**

Upheaval around Covid-19 has led to changes in established spending habits with more consumers experimenting and switching brands according to research by Radiocentre.

The industry body found that since the start of lockdown, 30% of commercial radio listeners have tried a new brand, 25% higher than non-listeners. The data highlights how 36% of commercial radio listeners are consuming more radio than they were before lockdown, listening for an extra 94 minutes each day on average.

Building on findings from an earlier study conducted during lockdown called Staying connected during the coronavirus crisis which showed a similar increase in numbers listening to more radio vs. pre-lockdown (+38%) this indicates that new listening behaviours been established whether people are at home or back in the workplace.

The research, Radio and the road to recovery, also shows commercial radio listeners are 54% more likely to be influenced by advertising as one of the main reasons for swapping their usual purchase for something new.

The research, which was unveiled at Radiocentre's Tuning In: Back to Business conference also investigated listening habits as lockdown has eased and people have begun to return to work and reveals that uplifts in radio listening captured in early lockdown have been maintained following relaxation of lockdown measures.

The research conducted by DRG also found that a third (31%) of those surveyed said that they are resuming normal shopping and social activities – especially true of key workers and those returning to work. Those working from home are also leading the charge in supporting the local economy, with 46% spending more in their local areas (compared to 31% on average).

Mark Barber, Radiocentre Planning Director, said: "We may be in a time of upheaval but research can play an important role in helping brands respond to changing attitudes and behaviour. While there are clearly challenges ahead this research highlights that there are also opportunities for brands to use advertising to trigger brand switching – especially with commercial radio listeners. ## LPAM Stations

### **Panjab Radio Fined by Ofcom .....20 September, 2020**

Ofcom has found Panjab Radio in an extremely serious breach of broadcasting rules on incitement of crime and offensive content.

The station, which is a faith and cultural service for the UK Asian community broadcasting in Punjabi, has been given a £30,000 financial penalty.

The regulator says its investigation found that during the Shamsher Singh Rai Programme, the presenter encouraged listeners to take the law into their own hands, and to carry out violent attacks against people he considered to have disrespected the Sikh faith.

On 24 August 2018 at 10pm, the Licensee broadcast a Punjabi poetry and listener call-in programme, in which the presenter discussed acts he perceived to be sacrilegious and how he believed people should react to them.

Reacting to the news, Panjab Radio posted this statement on its Facebook page: "Costing Panjab Radio around £80,000 including legal fees and Ofcom fine of £30,000. This has caused us huge anxiety and uncertainty over the last 2 years. "We are pleased this matter is finally over, but the long term consequences may be severe."

"We concluded this was an extremely serious breach of our rules on incitement of crime and offensive content, which warranted the imposition of statutory sanctions," Ofcom said.

- 960 CKNT Mississauga ON – Applied to increase Ethnic programming from 15% to 22% per week, and to modify its English language programming to include World Music with announcing using some non-English words to help newcomers improve their English.
- 1040 CJMS St Constant QC – The station did shut down at midnight August 31, but returned to the air the next morning. They have apparently applied to the CRTC for an appeal to the decision to pull their license. So they are back on until a decision on the appeal has been made.

- 1200 CJRJ Vancouver BC – Short term license renewal expiring August 31 2023 due to multiple failures to meet conditions of license.

- 1410 CJWI Montréal QC – (Incorrectly listed as "St Constant" in the government's Spectrum Management System). Short term license renewal, expiring August 31 2022, due to numerous failures to meet conditions of license. The CRTC also issued three new Mandatory Orders to emphasize the severity of these failures.
- 1490 CHTO-1 Mississauga ON – Construction Permit expired September 1 and no extension has (yet) been announced. There are no confirmed reports of the station being on the air yet. Was licensed to simulcast CHTO-1690 Toronto with non-directional 23 watts day and 770 watts at night, to improve night-time coverage in the west end of Toronto, especially Brampton, Etobicoke and Mississauga, which are areas where CHTO-1690's signal has been inadequate at night since CJLO-1690 Montréal came on the air more than 10 years ago.

## The Shift

The Shift continues overnights, seven days a week, on AM across Western Canada and Ontario, despite the premature departure of its Australian-accented creator and host, Drex. The show now uses one or two person rotating hosts from various locations, such as Shawn Hewitt from Calgary, a freelancer and past fill-in host for Drex. Each hour ends at :55 with the host identifying himself, then music until each station inserts its own ads and News at the top of the hour.

The Shift began as a replacement for Coast to Coast on the Corus-owned stations that aired it. The show continues to be aired Live, allowing immediate listener feedback by text, e-mail or telephone. Recent on-air monitoring in Edmonton verified the simulcasting on CHNL, CHED, CJOB, CHQR and CKNW.

## iHeartMedia Acquires WWRL New York For Black Information Network



iHeartMedia has announced it will purchase 1600 WWRL New York to join the Black Information Network.

iHeartMedia will begin operating WWRL via Local Marketing Agreement (LMA) on November 2. Currently owned by NJ Broadcasting, terms of the deal were not disclosed. WWRL currently airs Brokered Asian Programming supplied by India's "Radio Mirchi".

WWRL was New York's heritage R&B station from the 1960s through early 80s when it would then switch to Gospel and later Black Talk. That heritage ended in 2006 when the station became the flagship for the now-defunct Liberal Talk "**Air America**" network.

The station joins other BIN markets across the country, including the Atlanta, Augusta, Baltimore, Charlotte, Cleveland, Columbus, Dayton, Detroit, Greenville, Macon, Minneapolis, Montgomery, Nashville, New Orleans, Norfolk, Philadelphia, Riverside, San Francisco, St. Louis, Seattle and Washington, D.C. markets, bringing the number of BIN markets to 22 with more to be announced.

## Salem Exits Miami



Salem Media sells Spanish Christian "Radio Luz" 1450 WKAT/101.9 W270CV Miami to Nelson Voltaire's Radio Piment Bouk for \$3.5 million. The deal includes the transmitter site that is home to WKAT and Voltaire's Haitian "Radio Piment Bouk" 1360 WQVN North Miami as well as Entercom Sports "560 The Joe" WQAM Miami.

The deal also includes a license for the buyer to utilize the "Radio Luz" trademark of Salem's as long as the station retains its current format and is not sold to a third party. An LMA will take effect on October 1.

The sale of WKAT marks Salem's exit from Miami as the company previously sold WQVN (then the home of the WKAT call letters) to Voltaire in 2017 and then sold 880 WZAB and 1080 WQOS (at the time home of the WKAT calls) along with two stations in Tampa to iHeartMedia for \$8.2 million last year.



# Detroit, Atlanta, Carrollton - One Hundred Years of Radio Broadcasting History

August 20 marked the 100th anniversary of radio broadcasting. On that date in 1920, The Detroit News put radio station 8MK on the air. The call letters were changed to WBL in October with a limited commercial license, then to WWJ in March of 1922.

There are those who will assert that, in fact, WWJ was not the first broadcaster on the air. They will point to radio station KDKA in Pittsburgh, Pennsylvania which bills itself as the "Pioneer Broadcasting Station of the World." It traces its beginning, initially using the temporarily assigned "special amateur" call sign of 8ZZ, to its broadcast of the 1920 Harding-Cox presidential election results on the evening of November 2.

While historians debate the question, natives of Detroit and Pittsburgh will each passionately argue that their station was, indeed, the first (and probably the best). Both stations can uniquely claim several firsts, but there is a distinction between the two which might more accurately affect how one views the issue.

WWJ was the first commercial station in the world to broadcast daily programs, commencing with that initial transmission on August 20. There is little doubt about that assertion. Certainly, there were other experimental stations which had previously broadcast occasional programming content (as opposed to two-way communications) including music, some news and other features several years before WWJ took to the air. In comparison, KDKA reports that it was the first commercial broadcaster, being fully licensed as a commercial station when it started up. WWJ was not licensed until later even though it had provided daily service since its August sign-on. Also, WWJ operated under three different call letters, but was, in fact, on regularly since the August 20 sign-on.

It appears that while the station was established and funded by the newspaper and located in the paper's building, the original amateur license was issued to Howard Bowman of Detroit. Bowman was an employee of The Detroit News. That arrangement apparently continued until October 13 when the newspaper took over the license.

Thus, the distinction between the two was in the difference in licensing in that WWJ's original status was under an amateur license to an individual while KDKA's was as licensed to the broadcast entity from the start, albeit with a "special amateur" status.

To the listeners, the point was probably unknown and unimportant. Both were broadcasting stations offering programming to the general public and each making history in those early days of radio.

WWJ initially broadcast between 7 and 8 p.m., and programming consisted primarily of phonograph records interspersed with announcements. Early airings included fight results from the heavyweight championship bout between Jack Dempsey and Billy Miske on September 6 and a playby-play account of the Cleveland Indians-Brooklyn Dodgers game in the World Series. Weekly vocal concerts were begun in September with Mabel Norton Ayers as the first featured artist.

By October, The Detroit News reported that “hundreds” of Detroiters had wireless receiving sets on which they could hear the news and other features sent out by “The News Radiophone.” WWJ also broadcast the results of the presidential election in November.


Initially, WWJ did not pay performers but attracted numerous personalities to appear on the air including Lillian Gish, Fanny Brice, Babe Ruth and Ty Cobb. The station is believed to have been the first to broadcast news reports regularly and the first to also carry religious services and play-by-play sports.

The WBL call sign was randomly assigned but the newspaper soon found that listeners had difficulty hearing it correctly. The regional Radio Inspector was asked to change it to something more phonetically distinct, such as WKL or WWW. However, since neither was available it was assigned WWJ on March 3, 1922.

In 1923, The Detroit News complained that it was forced to cut back some of its hours to a competitor, the Detroit Free Press, which had established its own station WCX (now WJR) on the same frequency.

In an interesting side note: while WWJ and KDKA have vied for recognition as the “world’s first radio station” (as WWJ used to promote itself on the air in the 1940s and 1950s), radio station KCBS in San Francisco also claims the title of “first” by tracing its history to a pre-World War One station operated by Charles “Doc” Herrold in San Jose, California. The station made test transmissions in 1909 and began broadcasting weekly concerts in 1912. Herrold’s San Jose broadcasts were suspended during World War One when the U.S. government prohibited the operation of civilian radio stations, and after the war ended he did not return to the airwaves until 1921.

### Closer to home



Initially the first broadcast radio stations were established in northern cities such as Detroit, New York City, St. Louis, Cincinnati and others. But it wasn't long until a new venture in Georgia led to the first southern station.

*March 15, 1922 telegram authorizing WSB to immediately begin "news, entertainment and such matter" broadcasts on 360 meters (833 kHz) and weather reports on 485 meters (619 kHz)*

On March 15, 1922, the Atlanta Journal licensed the first commercial radio station in the south under the call letters WSB. The “Voice of the South,” as it was called, broadcast from the fifth floor of the Journal building on two frequencies – one for entertainment, and the other for news and market information. It was the 27th radio station in the United States to take to the air. Before the station started the Journal published instructions on how to build crystal-set receivers

The station went on the air with two 90-foot wooden masts supporting a crude antenna on the roof of the newspaper building and a power of just 100 watts. Initially, the programming consisted of local talent singing or playing an instrument. It was said that anybody who wanted to get on the air simply had to provide their own program and could have any time they desired. Anyone who could “sing, whistle, play a musical instrument, talk or even breathe heavily” appeared on the air according to one of the earliest performers. While unusual by today’s standards, radio then was such a novelty that listeners enjoyed almost anything.

Not to be outdone, the then-rival Atlanta Constitution newspaper launched its own radio station, WGM, on March 17 of the same year. Although this broadcaster gained some national notoriety, it was shut down by its owner on July 29, 1923 after just over a year of operation. The equipment was donated to the Georgia School of Technology (Georgia Tech) where it was used by the school’s electrical engineering program in early 1924 to set up radio station WBBF which was later known for decades as WGST. Today it operates as WGKA.

In the early days, most stations did not have regular programming schedules, often broadcasting for fewer than 8 hours a day. The “invisible audience” of listeners could tune in for a mix of news, music, and commentary from the announcers. As three more stations began in the next two years, that “invisible audience” expanded. Radio came to Middle Georgia when Mercer University founded WMAZ (Macon) in 1922, primarily hosting sermons and speeches by divinity students. That same year, WPAX (Thomasville) began playing phonographs from the owner’s garage by holding a microphone close to a Victrola.

From the early 1920s until the late 1940s, West Georgia radio listeners had to tune in to the early Atlanta stations or, at night to one of the many 50,000 watt, clear channel powerhouses that could be heard across the country including WSM in Nashville, WHAS in Louisville, WLW in Cincinnati or even more distant stations such as WGN in Chicago, WJR in Detroit or WWL in New Orleans.

But then, WLBB in Carrollton went on the air in 1947. According to 2013 article about the station in the West Georgia Living magazine, a publication of the Times-Georgian, the call letters didn’t mean anything, but “listeners who tuned in to the station’s twangy, homespun music programs started the joke that the letters stood for “We Love Butter Beans.”

The station originally broadcast from the People’s Bank building on Adamson Square (now known as the West Georgia Technical College headquarters) using a 250 watt army surplus transmitter. As with the earliest stations, the bulk of the programming featured musicians who would go to the studios and perform live.

Ken Denney, who wrote the story, reported that “in addition to “Uncle” John Patterson, there were groups with such names as “Charles Cole and His Southern Kinfolks,” the “Radio Homefolks,” the “Georgia Playboys” and “Joe Tyson and His Farmhands.” All made regular appearances on the station, sometimes attracting a live audience which watched them from behind a plate glass window.”

Evidently at the beginning there were no national network programs. Everything was produced locally. And, Denny said, “for the local musicians, it was strictly pay-to-play; they had to pay WLBB for blocks of air time, usually 15 minutes. Most musicians found sponsors or passed the hat among their neighbors; for some, that got easier over time as radio exposure made them local stars.”

Later, a popular DJ named Bob Green managed WLBB and kept one foot planted in country music’s Top 40 present and the other in the station’s hillbilly past. Until the station changed owners and management in 1963, Green not only spun the latest discs but hosted several live music programs as well. In addition to up-and-coming local country singers like Clyde Durrough and Marshall and Pearl Hannah, Green provided an outlet for older, more traditional performers such as Alton Stitcher and Uncle John Patterson, the “Banjo King.”

Today, the station is owned by Steve Graddick of Bowdon who operates it along with several other AM and FM stations in the area. Over the years the station had operated under various call letters, including WBTR and WPPI. Graddick returned the original call letters in 2001.

For us, it is sufficient to say that the impact of broadcast media, whether radio or television or online podcasts or whatever have brought us together, informed, inspired and, indeed, divided us as a people. But, the efforts of the founders and broadcasters since the 1920s have certainly made us better informed and entertained.

# A Background to the WNJC 1360 AM DX Tests

John "Duke" Hamann, KC2DUX, WNJC fb via Thomas Nilsson



I wanted to take a moment to explain to everyone why I am doing all these DX tests. I have been working for WNJC 1360 AM for the past 25 years (I started there when I was 15) and have been the chief engineer for the last 20 years. It was where I learned a lot about RF and broadcasting. I am also an Extra Class Ham Radio Operator, KC2DUX and I have 2 amateur radio repeaters located at WNJC, 147.120 and 927.6375 co-owned with Joe Glessner\_(N2YIR).

Over the years, the station has had its fair share of problems, mostly caused by lightning and copper theft. Several times thieves had removed just about every bit of copper from the site and I always had to come up with some jerry rigged temporary fix. As the years went on the owner never wanted to spend money to fix it the right way. 3 years ago the owner, John Forsythe passed away and his wife gave the station to one of the longtime show hosts. The station was really behind on bills, the studio lease was up, the transmitter site was severely overgrown and in shambles and we were operating under an STA running on a 1000 watt transmitter (when the electric was on) running on tower 3 as it was the only one we had good coax going to.

To my surprise, when the new owners came in, they actually wanted to fix the station right. We built a brand new studio, Mike Patton and Associates rebuilt the SX5-A transmitter and Joe Glessner and myself spent a year and a half rebuilding and restoring the tower site from the ground up. New transmission & monitoring coax cables, new power wires, rebuilt the ATUs, replaced the strobe lights on the tower, rebuilt the phaser, replaced the lossy steel unipoles with copperweld, rebuilt the entire ground system above and below ground. An easy \$250,000 project.

WNJC's tower site consists of 4 towers. Tower 1 (Northwest) is a 420ft guyed tower with a 220ft DC grounded folded unipole running up all 3 legs of the tower. Tower 2 (Southwest) is a 440ft guyed tower with a 220ft DC grounded folded unipole running up all 3 legs of the tower. Tower 3 (Northeast) & Tower 4 (Southeast) are 160 foot guyed insulated towers. They are phased together to create a directional pattern. During the nighttime, only Tower 1 and Tower 2 are in-use to create the directional pattern and during the day, all 4 towers are used.

All 4 towers use an elevated ground system, consisting of 6 runs of 350 ft of copperweld going off each tower every 60°.

So this is where the depressing part comes.... It's been just about 2 years since finally getting WNJC's tower site rebuilt, getting all caught up on all the bills and building an audience (at least during the daytime), we found out last month that the landowners of the tower site are not going to renew the 30 year lease. Now we have 6 months to find a new home and rebuild or give up the fight. The final decision has not been made yet. In the meantime, I wanted to take advantage of having control of what is broadcasted overnight. For the last 3 weeks I have run DX tests. The first weekend was a 6 hour per night, 2 night test running 1250 watts omnidirectional Saturday night and 5000 watts directional Sunday night. The second week I ran a 1 hour DX test on our regular nighttime pattern and power. The third week I ran a 1 hour DX test and 1 hour FT8 test running 1250 watts from Tower 1 (I had never used that for omnidirectional service before). All the DX tests have been quite successful. We have had confirmations from Sweden, Norway, Germany, Canada and all over the Eastern and Central states!

I plan on continuing these tests thru October and maybe even beyond. Tests will be all performed Sundays at 0400 UTC. QSL's can be sent to [k2dux@duxpond.com](mailto:k2dux@duxpond.com) or send a large SASE to Duke Hamann, PO Box 84, Dennisville, NJ 08214, USA.


The Courtesy Program Committee of the National Radio Club and International Radio Club of America are pleased to announce another DX Test. This time from **KSEN 1150 kHz in Shelby, Montana**, near the Canadian border. KSEN plays an oldies format with the slogan, “*Good as Gold.*” They’re a fixture in the Shelby area but can be difficult to log outside of Big Sky country.

This test for distant listeners is being done with the generous support of the owners of KSEN, station management, and Chief Engineer Todd Clark. We can also thank the efforts of CPC member Paul Walker who used his connections in broadcasting to arrange yet another test.

**The test will be on late night Saturday-Early Sunday morning on November 8, 2020 starting at 12:01AM Mountain Time for one hour. This is 0600-0700 UTC so it may be tough to log in Europe.**

Test will be at the daytime power of 10,000 watts, but we are not yet certain about which antenna pattern may be available for the test.

Todd is attempting to arrange a change to the ND pattern, but may be limited to the night pattern which favors the North and South, with nulls towards E-W.



Test will consist of voice announcements, Morse Code ID's, sweep tones, off-hook telephone sounders, etc. The station has a small staff, so they have asked the CPC Committee to handle reception reports and verifications. Verifications will be by e-mail only. A specially designed QSL card in Adobe PDF format will be sent to successful reports.

# 180 Radio Stations Closed in Venezuela Since 2009

In a recent report the Comité para la Protección de los Periodistas (CPJ) reflects on the offensive of the governments of Hugo Chávez and Nicolás Maduro targeting the independent press which among other things has resulted in the closure of 180 radio stations since 2009.

This offensive, which gets stronger by the day, according to a recent report, is part of a wide-ranging campaign to silence political opposition and human rights activists.

The CPJ states that "it has documented the adoption of a series of measures including the detention of journalists which has resulted in a weakening and deterioration of the Venezuelan media."

The attack on the media began in August 2009 when the government of the then president Hugo Chávez suspended the licenses of 32 radio stations in a single day starting a wave of closures over the next decade using censorship and other measures.

The CPJ makes reference to data compiled by Espacio Pública, a Venezuelan organisation defending the freedom of expression, which details the year by year and state by state closures of the 180 stations between 2009 and 2019.

The years with the most closures were 2017 with 57 stations, 2009 with 32, 2019 with 27 and 2011 with 23.

According to the report, "in the majority of cases it was due to direct orders from the authorities listing a variety of infractions including licenses having expired."

In other cases local authorities have deliberately interrupted the distribution of electric power or in other cases stations were forced off the air due to frequent power cuts or lack of petrol.

Radio broadcasting is essential in order to keep the Venezuelan public informed about current events and particularly in the more remote areas where many of the printed media have been forced to close. The blocking of the Internet is more frequent now and TV stations have had programming censored, according to the CPJ.

According to the report, the Maduro government has restricted information on the Covid-19 emergency in a context where there is a lack of basic necessities such as food, petrol and medicines.

Espacio Público says that nine radio stations have left the air during the first five months of 2020 including Rumbera 106.9 which was closed by CONATEL in May.

Station owners and directors of the closed stations told CPJ that the closures were ordered by officials of the CONATEL who arrive accompanied by members of the National Guard or other military or police forces.

The director of Caracas Radio (RCR), Jaime Nestares Phelps, explained that the closures have been accompanied by a number of other measures including the seizure of equipment or, on some occasions, the destruction of offices and equipment and when attempts are made to complain at local police stations they receive no response.

The closure of radio stations often occur in connection with popular protests or political unrest or when the media have covered sensitive subjects or activities by the political opposition according to an analysis of the events made by the CPJ after interviews with the owners of the radio stations.

The situation leaves the Venezuelan public at the mercy of the government-run radio stations, the report says.


CPJ has tried to obtain comments from the Ministry of Communications and Information and from CONATEL but with no success.






Ett trevligt QSL som Lars Rydén LR fick från CFRN i Edmonton, Alberta år 1960. Motivet är Weahna of Sunwapta som målade av den kanadensiske konstnären Dorothy Oxborough (1922-2014). Weahna betyder den lilla och motivet användes flitigt i stationens annonsering. CFRN startade redan 1927, då som CHMA 580. I dag kör stationen ett sportformat på 1260 kHz med slogan *The Team 1260* och är relativt vanlig.




Ytterligare en kanadisk från LR:s samling: CFRB i Toronto, Ontario. Relativt vanlig på 1010 kHz när konden rör sig inåt landet. Även denna station startade 1927 och är därmed den äldsta Torontostation som fortfarande är aktiv. CFRB kallar sig *Newstalk 1010* och har som slogan *Toronto's breaking news, traffic, and weather*. Detta är en av de få kanadastationer som finns kvar på kortvåg där man kör med 1 kW på 6070 kHz. Båda lär återkomma under säsongen.



Från Toronto till Maine. WLAM kör ett trevligt oldiesformat på 1470 kHz och är njutbar lyssning när inget ovanligare hörs på frekvensen. Tore Larsson TL, ARC:s ständige sekreterare, fick svar från stationen 1962. I motsats till Svenska Akademien har vi ju verkligen en ständig sekreterare och inte en "tillfällig ständig sekreterare" som det hette när det bråkades som värst inom detta vittra sällskap. WLAM startade 1947 och servar området Lewiston-Auburn. Callbokstäverna står för Lewiston Auburn Maine.





*Many Norwegian and Swedish sailors settled in Australia during the mid to late 19th century.*

*Eidsvold however was named by two Scottish settlers who had previously lived in Norway in the 1820s and so indeed did name Eidsvold after Eidsvoll as you speculated."*




